### Required for Enrollment

To secure a space for your child, the enrollment form, registration fee, one-week deposit, and first week's tuition is required. The deposit will be credited towards your last week's tuition with a withdrawal notice of four weeks.

### Sibling Discount

We offer a 5% sibling discount on the total tuition for families with more than one child enrolled at Concordia.

### Sliding Scale Tuition

Determining Household Income: Tuition is based on your child's program (not age), the total gross income for your household, and family size. For each additional child in your family, we give a \$5,000 consideration to determine the tuition category. If your income is less than \$85,000, you must provide a copy of your most recent IRS Tax Statement or proof of income. Otherwise, your tuition is the highest category.

### Other Fees

- An Annual Registration fee (per child) is due each spring and is based on total gross household income: \$150 for families over \$85,000, \$120 for families \$50,001-\$85,000, \$80 for families \$35,001-\$50,000, and \$50 for families under \$35,000. If you registered after December 31, your registration fee is waived for the next program year.
- For School-Age 365, after-school program hours are extended to accommodate when area schools are closed during the school year. There is an additional \$15 charge for full-days.
- We accept subsidies through IDHS (Illinois Action for Children). Families with these subsidies pay an additional weekly fee per enrolled child in addition to their IDHS co-pay: \$25-1st child, \$20-2nd child, \$15-3+children.
